4. The deadline for receipt of your quotation (s) by the hiring agency at the address indicated in Paragraph 1 is 18-04-2019 till 1100 hrs.
5. **Your quotation(s) should be submitted as per following instructions:**
 - (i) **PRICES:** The prices should be quoted for supply/ delivery and installation of walk in tunnel at WMRF, Renala Kurd, Okara to **Director Water Management Training Institute, Thokar Niaz Baig, Lahore** . Prices shall be quoted in Pak Rs. inclusive of all applicable taxes.
 - (ii) **EVALUATION OF QUOTATIONS:** Offers determined to be substantially responsive to the technical specifications will be evaluated by comparison of their prices. In evaluating the quotations, the hiring agency will determine the evaluation price for each proposal by adjusting the price quotation to correct any arithmetical errors as follows:
 - (a) Where there is a discrepancy between amounts in figures and in words, the amount in words will govern;
 - (b) Where there is a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern;
 - (c) If a Supplier refuses to accept the correction, his quotation will be rejected.

In addition to the quoted price, the evaluated price shall include Value Added Tax (VAT) in **Pakistan** (in case of any exemption the firm will provide documentary evidence)

- (iii) **AWARD OF WORK:** The work order will be issued to the bidder offering the lowest evaluated price and that meets the required standards of technical and financial

capabilities.

- (iv) **VALIDITY OF THE OFFER:** Your quotation(s) should be valid for a period of forty five (45) days from the deadline for receipt of quotation(s) indicated in Paragraph 5 of this Request for Quotation.

 7. The Purchaser intends to apply for funds from the World Bank for eligible payments under the Purchase Order resulting from this RFQ.




